1. **This Invitation For Bid follows the General Procurement Notice for this Project that appeared in the Development Business on 21st September, 2016.**
2. The Government of India has received financing from the World Bank towards the cost of National Hydrology Project and intends to apply a part of the funds to cover eligible payments under the contract for construction of works as detailed below.
3. Bidding will be conducted through National Competitive Bidding procedures agreed with the World Bank. Bidding is open to all eligible bidders as defined in the World Bank's Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers, January, 2011 (Revised in 2014).
4. Bidders from India should, however, be registered with the **Government of Mizoram** or the other State Governments / Government of India, or State/Central Government Undertakings. Bidders from India, who are not registered as above, on the date of bidding, can also participate provided they get themselves registered by the time of contract signing, if they become successful bidders. **Bidders are advised to note the clauses on eligibility (Section I Clause 4) and minimum qualification criteria (Section III – Evaluation and Qualification Criteria), to qualify for the award of the contract.** In addition, please refer paragraphs 1.6 and 1.7 of the World Bank's Guidelines setting forth the World Bank's policy on conflict of interest.
5. The Superintending Engineer, PWD, Project Circle (Entrusted by the Implementing Agency) invites sealed bids for the construction of works detailed below in the table. The bidders may submit bids for the works indicated therein.

6. Bidding documents (and additional copies) may be purchased from the office of **the Superintending Engineer, PWD, Project Circle** from **14.02.2019** to **27.02.2019** for non - refundable fee (three sets) as indicated in the table, in the form of cash or Demand Draft on any Scheduled/Nationalized Bank payable at **Aizawl** in favour of **the Superintending Engineer, PWD, Project Circle**. Interested bidders may obtain further information at the same address. Bidding documents requested by mail will be dispatched by courier/speed post on payment of extra amount of **₹.500**. **The Superintending Engineer, PWD, Project Circle** will not be held responsible for postal delay if any, in the delivery of the documents or non-receipt of the same.
7. All bids must be accompanied by a bid security of the amount specified for the work in the table below, drawn in favour of **the Superintending Engineer, PWD, Project Circle**. Bid security will have to be in any one of the forms as specified in the bidding document and shall have to be valid for **45 days** beyond the validity of the bid.
8. Bid must be delivered to the **Superintending Engineer, PWD, Project Circle** on or before **1200 hours** on **5th March, 2019** and will be publically opened on the same day at **1230 hours**, in the presence of the bidders designated representatives who wish to attend. If the office happens to be closed on the date of receipt of the bids as specified, the bids will be received and opened on the next working day at the same time and venue. Late Bids will be rejected.

A pre-bid meeting will be held on **25th February, 2019** at **1300 hours** at the office of the **Superintending Engineer, PWD, Project Circle** clarify the issues and to answer the questions on any matter that may be raised at the stage as stated in **ITB Clause 7.4** of '**Instructions to Bidders**' of the bidding document.
